



nis chart shows the total general purpose revenue JCS-Pine Valley expects to receive in the coming year from all sources. The text description for the above chart is as follows: The total revenue projected for JCS-Pine Valley is \$2,526,637, of which \$2,061,705 is Local Control Funding Formula (LCFF), \$336,080 is other state funds, \$14,846 is local funds, and \$114,006 is federal funds. Of the \$2,061,705 in LCFF Funds, \$168,809 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

This chart provides a quick summary of how much JCS-Pine Valley plans to spend for 2024-25. It shows how much of the total is tied to planned actions and services in the LCAP.

The text description of the above chart is as follows: JCS-Pine Valley plans to spend \$2,688,772 for the 2024-25 school year. Of that amount, \$510,000 is tied to actions/services in the LCAP and \$2,178,772 is not included in the LCAP. 
The LCAP is written as a focus goal plan for school improvement. It has been developed based on needs identified through data analysis and partner impact. Basic operational costs, such as general education salaries/benefits, are general fund budget expenditures that are not included in the LCAP.

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, JCS-Pine Valley is projecting it will receive \$168,809 based on the enrollment of foster youth, English learner, and low-income students. JCS-Pine Valley must describe how it intends to increase or improve services for high needs students in the LCAP. JCS-Pine Valley plans to spend \$179,375 towards meeting this requirement, as described in the LCAP.

Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

1.3 - Not all students are using CCSS aligned curriculum in our Academy program because some teachers are creating their own learning activities, assignments, and assessments. The teachers are using their knowledge of the CCSS standards to create these activities but we have not adopted curriculums as a vehicle for teaching and learning.

1.5 - We are not using the Georgia Numeracy math curriculum. All other parts of the Staff Development action were carried out as planned. 1.7 - We did not pilot any new math supplement programs this year. All other parts of the Math Program Analysis action were carried out as planned.

1.11 - We did not purchase texts to develop a more diverse book collection in English and Spanish to support students' independent reading, as planned. Our EL Home Study population preferred to utilize their local libraries and our EL Academy students relied more on free online translation resources.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

1.1 - We were approximately \$25,000 over budget for Instructional Devices. Due to incompatibility of some of our older Chromebooks and the state's updated secure test browser, we had to purchase more devices than we had originally budgeted.

1.2 - We were under budget for Internet & Instructional Materials to provide in-home internet for LI/FHY and printed materials, as needed. We over-estimated these expenditures and provided the resources (ex. wifi hot spots) to all students and families that indicated a need.

1.3 - We were under budget for CCSS Curriculum & Materials. We have carried out the action as planned for our Home Study population but many of our Academy teachers are creating their own materials; therefore, we did not spend as much as on CCSS Curriculum and Materials as planned.

1.4 - Due to our small population on English Learners, we did not need to spend as much as we planned on ELD curriculum. This action was carried out as planned and all English Learners are using designated ELD curriculum aligned to the ELD framework.

1.9 - We partially designated one of our Educational Faciliators as a TK-3 Specialist to support this action; therefore, we were approximately \$8,000 over budget.

1.11 - We did not purchase texts to develop a more diverse book collection in English and Spanish to support students' independent reading, as planned. Our EL Home Study population preferred to utilize their local libraries and our EL Academy students relied more on free online translation resources.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

One action we have determined may be ineffective is the use of CCSS Curriculum and Materials. Although 100% of students have access to standards-aligned materials, we have evaluated that some of the adopted curriculums in our Home Study program may not be engaging or rigorous enough. Likewise, many teachers in our Academy program create their own curriculum for core subjects and we think that adopting some quality resources and using them with fidelity will support the improvement of learning outcomes and state assessment scores.

We provided internet and instructional materials for our Low-Income students and believe this action was effective in supporting student learning and closing equity gaps. On the Spring 2023 state test, the performance of low-income students improved in both ELA and Math and the desired outcome identified in the DFS for Math metric above was obtained. Additionally, we believe actions related to professional development and math program analysis in our high school program were effective in increasing academic achievement for our 11th-grade students, as evidenced by the increased percentage of students considered Conditionally Ready or Ready in ELA and Math on EAP.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

24/25 introduces a new LCAP with new 3-year goals, metrics, desired outcomes, and actions. In the new LCAP, we have categorized the 8 state priorities and written 3 broad goals in the areas of Conditions of Learning, Student Outcomes, and Engagement. This approach has resulted in a reorganization of metrics and actions. For instance, actions related to accessing curriculum and materials are basic services in the new Conditions of Learning goal. Actions related to student performance on CAASPP, CAST, and MAP are in the Student Outcomes goal.

In the new LCAP, we are not including a metric for 9th graders enrolled in transitional math as our actions and services have been effective in reducing this. We will also shift our focus on MAP data to primarily measuring growth over Fall, Winter, and Spring testing windows within a single school year and rely on CAASPP to provide an accurate reflection of student achievement.

As we look at the future of our school, we intend to re-evaluate the standards-aligned curriculum at use in our Home Study and Academy program. There is a strong push for alignment within our Home Study program that could support the reevaluation of recommended core curriculums and the adoption of additional engaging and standards-aligned materials and recourses to be distributed through our Resource Center for all students. Within our Academy program, some core teachers are creating their own standards-aligned materials and, to impact student learning and increase student outcomes, we want to adopt CCSS aligned curriculum in all of our core Academy classes.

Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

2.2 - We provided two paraprofessionals to support the MTSS action. Due to a lack of resources, we did not provide a formal MTSS process but we did provide the associated services such as academic tutoring and counseling, positive behavior supports, mental health services, and other extracurriculars.

2.3 - We were not able to provide an SEL curriculum and oversee tiered strategies to address SEL needs. We also did not provide a campus counseling program through a community agency due to a lack of resources.

2.4 - In addition to providing an EL Coordinator, we also provided a partial EL teacher to meet regularly with students online in a synchronous environment to provide speaking and listening support and practice.

2.10 - We offered a Health Class so students could learn about nutrition and we provided physical education classes and outdoor activities at the Academy and Learning Center, primarily taught by core staff members. We originally intended to add a staff member as a Health and Wellness Coordinator but we were unable to do this due to a lack of resources.

2.2 - We were over budget for the MTSS action because we provided two paraprofessionals at our Academy to support learning acceleration.

2.3 - We lost our SEL counselor over the summer; therefore, we spent less than planned for the SEL action.

2.4 - In addition to providing an EL Coordinator, we also provided a partial EL teacher; therefore, we spent more on this action than planned.

2.9 - Due to an increase in overall enrollment and our populations of underserved students, we provide more meals and spent approximately \$2,000 more than planned.

2.10 - We were under budget for the Health & Wellness action because we did not provide a staff member to coordinate educational opportunities for a healthy lifestyle.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Our actions for supporting students to grow in a Multi-tiered System of Support were either ineffective or not carried out as planned due to lack of funding, lack of data, or leadership transitions. In 23/24, we utilized resources to measure academic achievement and growth throughout the school year (ex. NWEA MAP) but we did not execute a formal RTI process with SST meetings and intervention plans. Even so, our staff analyzed data together and made Tier I instructional decisions based on the needs of our students.

We administered the Holistic Student Assessment (HSA) and used Securly to screen students' online engagement for mental health needs but we were unable to actively address identified needs with tiered strategies without the support of a SEL counselor or counseling program through a community agency. Even so, ongoing SEL at the Academy was provided as part of the classroom culture and management systems and SEL resources were provided to parent-teachers in the Home Study environment. Training for staff was provided through required annual HR training courses.

Our EL population remains very small and retention from year to year is low. Although our EL coordinator and EL teacher communicated about ELD progress and provided opportunities for synchronous, online ELD instruction, participation, and work completion rates were low in 22/23, resulting in 0% of EL students growing one ELPI level. On a parent survey given in Spring 23/24, 100% of EL and SwD parents indicated they felt "highly supported" by the school. We hope this is a reflection of increased services and that our 23/24 EL data will be more positive.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

As we continue to focus on our MTSS program in the 24/25 LCAP, we plan to reinstate our RTI program and intend to identify additional RTI metrics for students in grades TK-1 so we can measure and report their progress. We also need to explore cost-effective ways to provide quality SEL support, whether with our staff or community providers. In 23/24, our school network "soft-launched" the Beyond SST program to bring improved consistency, structure, and accountability to our MTSS program. Beyond SST and actions allowing us to create the capacity to implement and sustain a quality MTSS program will be included in the 24/25 LCAP.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

3.3 - We were under budget for the College Credit Course Access. We carried out the action as planned but less students participated by taking the community college courses we offered and promoted.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The focus of this goal was to increase the percentage of students who graduated College and Career Ready and, in 22/23, 42% of our graduating seniors met College and Career Preparedness requirements. Our primary strategies included increasing access to a-g courses (adding foreign language and electives) and dual enrollment opportunities and we were successful in meeting our desired outcome for both these metrics.

Other actions which were effective in helping us make progress toward the goal included the High School Counselor, Field Trips, and Bound for Blue. We funded a high school counselor who was instrumental in supporting College and Career Readiness within our school by counseling students in college/career paths and requirements, monitoring a-g courses and access, and analyzing transcripts. We provided field trips to local businesses, junior colleges, and state universities. Our Bound for Blue program continues to promote and incentivize students to complete milestones and the path to becoming College and Career Ready.

Despite our progress to support College and Career Readiness, JCS-Pine Valley does not have enough high school students to populate the College and Career Indicator on the CA Schools Dashboard.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

College and Career Readiness is a priority for our school; therefore, many of these metrics and actions will be continued in the 24/25 LCAP appearing primarily in Goal #2 (Student Outcomes). We will continue to increase a-g and dual enrollment course access while exploring partnerships that will provide students with access to CTE pathways in the new 24-27 LCAP cycle. At this time, JCS-Pine Valley does not intend to invest resources to promote access to AP courses.

General Information

JCS-Pine Valley is an independent study TK-12 charter school sponsored by Mountain Empire Unified School District. JCS-Pine Valley serves 170 students in east San Diego County. Currently, the school has one center in Pine Valley, Pine Valley Academy, which houses a 6-12 academy that students attend 3-4 days per week. Additionally, there is space for educational facilitators (EFs) to meet with Home Study students and space for special education services.

The mission of JCS-Pine Valley is to empower learners with educational choice. Our vision is to work in partnership with families to ensure all learners develop the necessary skills to become contributing members of our local and global communities. Our school's theme is cultivating character. Our students are very involved in community events, community service, recycling, responsible stewardship of nature, ASB activities, and school events, We also encourage global awareness and strive to step out of our comfortable town and into the world around us. We are dedicated to excellence and committed to nurturing passionate lifelong learners. Core values include:

- Creativity and Innovation: Envision and explore rich teaching and learning opportunities.
- Commitment: Educate students to their full potential and uphold the greater good of the school.
- Choice: Empower individual paths and goals through personalized learning.
- Excellence: Foster a climate of high expectations, quality, and accountability.
- Integrity and Compassion: Model honesty, dignity, fairness, and responsibility while demonstrating respect and understanding.

Students at JCS-Pine Valley are part of an independent study education model and are generally referred to as being in the home study program or the academy program. Daily instruction of TK-12 home study students is done by the parent-teacher under the supervision of an EF. K-8 students may get instruction one day a week at a learning center or the EF may work with the parent to incorporate instruction from our educational enrichment partners. Students at our 6-12 academy are taught by a certificated teacher less than 74% of the time and by a parent-teacher more than 26% of the time. Our student population at Pine Valley consists primarily of white students (80.1%) and Hispanic/Latino (21.6%) students. Our special education population is somewhat larger than traditional districts, with an overall percentage of 15.8%. Due to the nature of independent study, our English language learner population is fairly small (2.3%), since for at least a portion of the week the parent is the teacher of the student. Our socioeconomically disadvantaged population is 44.4%, and our homeless and foster youth make up 3.5% of the population. While we don't have a migrant population in the traditional sense, we do have a somewhat transient population. Some families decide that home study is not the right "fit" for them, while others move back and forth between different charter schools looking for different resources and schedules. Our 6-12 academy, however, has a consistent base of students who typically stay with us through graduation once they start.

Students come to JCS-Pine Valley for various reasons: some are looking for an option other than their local school because they aren't happy with what their local school has to offer; some are drawn to the academy because of its project-based program or smaller classes; others like the balance of home school and classroom-based instruction; and still others prefer the traditional home study model with the flexibility and choice in curriculum and daily schedule. Because JCS-Pine Valley covers a relatively large geographical area, our student demographics and needs vary somewhat depending on the region. As a school, we look at data for the academy and home school separately, and as a whole to identify our students' needs. While JCS-Pine Valley strives to support all learners in meeting their potential, we are very aware of our struggling and at-risk learners and their diverse needs and are constantly striving to provide additional support.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The 2023 CA School Dashboard was released in December 2023 and revealed areas of academic performance and engagement where JCS-Pine Valley is improving or declining. This information allows us to reflect on the effectiveness of actions/services in the 23/24 LCAP and emphasizes areas where JCS-PV should focus actions/services in the 24/25 LCAP, especially related to equity for disadvantaged subgroups of students. For many engagement indicators and state-required metrics, data is not publicly available for JCS-PV students due to small enrollment numbers; therefore, we used local data and calculations to determine overall performance and equity gaps.

ELA Performance Analysis: Overall, 43.24% of all JCS-Pine Valley students met/exceeded the standard in ELA on the 2023 CAASPP. According to the CA Schools Dashboard, Distance from Standard (DFS) is 24.0 points below standard, a significant decline (16.7 points) from 2022 ELA CAASPP performance. This has placed JCS-Pine Valley in the "orange" performance category. JCS-Pine Valley's achievement on the ELA performance indicator is also lower than the state; therefore, improving ELA achievement and identifying effective actions/services to do so is an undeniable need.

From an equity lens, there is a significant gap among students with disabilities (SwD). Our SwD population performed below the overall population and only 21.43% of SED students met/exceeded the standard in ELA. There is a difference of 26.9% between SwD students and

non-SwD students, representing an equity gap of -26.9. In 2023, there was no equity gap for other significant subgroups such as socioeconomically disadvantaged students (SED) and Hispanic students. 43.9% of SED students and 53.3% of Hispanic students performed at/above the standards in ELA. Other subgroup, such as English Learners (ELs) and Foster/Homeless Youth (FHY) are too small to populate the CA School Dashboard and share data publicly. Moving forward and planning for our 24/25 LCAP, we will identify specific actions/services to close the SwD equity gap.

Math Performance Analysis: According to the CA Schools Dashboard, JCS-Pine Valley performed lower than the state in Math on the 2023 CAASPP. JCS-PV was placed in the "orange" performance category due to a DFS of 52.2 points below standard, a decline of 3.9 from 2022. 28.38% of all JCS-PV students met/exceeded the standard in Math on the 2023 CAASPP. Students with Disabilities (SwD) performed significantly lower in Math than the overall population with an equity gap of -17.4. Hispanic students had an equity gap of -10.5 and the gap for Socio-economically disadvantaged (SED) students was -3.5. An internal analysis of Math data by program highlights that Home Study students perform significantly higher than Academy students. 35% of Home Study students met the standard and 10% of Academy students met the standard.

CAST Performance Analysis: JCS-Pine Valley's overall performance on the CAST shows that 24.24% of students met/exceeded science standards, which is lower than the county and the state. SED students performed higher than the overall population of students at JCS-PV, but still lower than the state and the county. Other subgroups did not have enough students to share data publicly.

EAP Performance Analysis: Due to low enrollment numbers in 11th grade, public data for JCS-Pine Valley for EAP readiness is not available. An analysis of internal data tells us that 63% of students met the standard in ELA and 25% met the standard in math. Of our SwD in 11th grade, 67% met the standard in both ELA and Math. For SED students in 11th grade, 75% met the standard in ELA and 0% met the standard in Math.

EL Performance Analysis: Due to small student numbers, no public data is available for JCS-Pine Valley related to ELPAC Reclassification Rate. Internal data and calculations tell us that 0% of students grew an ELPI level on the Summative ELPAC from Spring 2022 to Spring 2023; therefore, we were able to reclassify 0% of students. Also, 0% of ELD students met/exceeded the standards in ELA and math on the state test.

In 2023-2024, we started using a new online ELD curriculum, SummitK12, for all students in grades K-3 and students in grades 4-12 with a Level 1 or 2 ELPAC score. EL Students in grades 4-12 with a Level 3 ELPAC score continued to use Achieve3000, another fully online curriculum. In addition to completing personalized ELD assignments with the online curriculum, all students met regularly with the school's designated EL teacher for speaking/listening activities. Students who participated regularly made significant gains in their Lexile scores and benefitted greatly from the additional interactions with a teacher. With the shift in ELD curriculum programming and the increased opportunities to engage in synchronous listening/speaking instruction with the ELD teacher, we hope RFEP rates and ELPI improvement rates will continue to increase.

The only student engagement indicators that populated the 2023 CA Schools Dashboard for JCS-Pine Valley were Chronic Absenteeism and Suspension Rate. JCS-Pine Valley was placed in the "yellow" or middle-performance level for status and change on the Chronic Absenteeism indicator on the 2023 CA Schools Dashboard. Our Chronic Absenteeism DFS for all students is 4.3%. Our SED subgroup was also placed in the "orange" or performance category, demonstrating an equity gap. 4.3 % of all JCS-PV students were chronically absent and

7.5% of SED students were chronically absent. JCS-PV is proud to have maintained 0% suspension and expulsion rates in 2023 for all students and subgroups. We will continue to promote strong SEL and leadership programs that increase student engagement and support behavior interventions.

In 2023, 23% of JCS-PV students met A-G Completion status. This percentage exceeded our desired outcome in the 23/24 LCAP due to actions/services to increase the a-g completion rate. We will continue to implement actions/services related to a-g completion. The 2023 drop-out rate for JCS-PV is 0% and the 2023 Graduation Rate was 100%. We are proud that our 2019-2020 cohort students all graduated!

On the 2023 CA School Dashboard, the College and Career Indicator is not available for JCS-PV. Regardless, preparing students for postsecondary experiences is a priority for the school and we have dedicated resources to increasing the % of students who meet a-g requirements and/or complete college credit courses over the next two years to better prepare students for college and career pathways. As a result, 23% of our high school students in Spring 2023 had completed a college credit course. Largely, this is a result of our partnership with Grossmont College and our support and encouragement of students to take Grossmont classes such as ASL and History of Rock.

We administered the Holistic Student Assessment (HSA) to students in 3-12th grade this year and observed that the % of students placed in Tier 3 (most significant SEL needs) has increased dramatically from 16% in 2020 to 35.6% in 2023. We learned that Emotion Control was the most common strength and optimism, perseverance, and empathy were the most common challenges. From the results of the HSA, it is clear that Hispanic students need the most significant SEL support and 75% of the Hispanic students who participated in the HSA are Academy students. Hispanic students have the highest percent of Tier 3 students (75%) with the lowest number of average strengths and the highest number of average challenges. Additionally, SwD have a high percentage of Tier 3 students (45.5%) and 75% of SwD students who participated in the HSA are in the Academy program. While these two groups have very different SEL strengths and challenges, they both require intense SEL intervention actions/services. In 2024, we hope to address the SEL needs of our students with the Leader in Me leadership program.

The 2023/2024 school year also introduced the Beyond SST program aimed at bringing more structure, consistency, and accountability to our MTSS efforts. The Beyond SST roll-out and subsequent professional training have allowed the school to continue working with teachers on clarifying processes and supports available to students while holding more routine SST meetings, implementing research-based intervention, and monitoring progress. Across all programs, we continue to emphasize the importance of participating in local common benchmark assessments to obtain valid growth data and identify students needing tiered support.

Since this has been an LCAP development year and the LEA was challenged with writing new goals for focused school improvement over the course of the next 3 years, we sought to develop a comprehensive plan for getting partner input. This included structured group forums/discussions around school improvement needs at the School Site Council meetings in January and May 2024, a two-minute conversation campaign (2MC) encouraging staff to gather direct, synchronous feedback to a "Question of the Month" as they interacted with parents, students, and colleagues (including teachers, principals, administrators, and other school personnel) from January - April, and staff/parent/student feedback surveys consisting of multiple choice responses, scaled rating responses, and short answer responses in April. Below is a summary of the partner feedback that was received.

School Site Council Discussion: Parents and staff suggest several ways JCS could better support students to achieve at high levels and cultivate a passion for lifelong learning. These include offering interventions tailored to specific challenges such as dyslexia, providing a detailed and easily accessible comprehensive list of intervention resources, identifying general education curriculums suitable for students with specific needs, and exploring intervention apps with proven efficacy, particularly for at-risk students. Additionally, they propose expanding offerings for home study students in math and reading, potentially through partnerships with programs like LIVE, increasing virtual instruction options, establishing a Tier II provider or intervention teacher for home study students, and offering more electives, including synchronous virtual instruction for the High School program.

Suggestions for enhancing the experience as a JCS student, staff member, or parent-teacher include increasing sports offerings through partnerships with local organizations and introducing intramural sports within JCS. Additionally, there's a proposal to raise personalized funding allowances for Home Study students, streamline the onboarding process for the Educational Enrichment Program (EEP), improve customer service response times for EEP vendors, and appoint an EEP recruiter to facilitate recruitment efforts. These ideas aim to enrich the overall experience and provide greater opportunities for engagement and participation within the JCS community.

Parents highlight areas where other schools offer opportunities that JCS currently does not, including student events and engagement, a streamlined Educational Enrichment Program (EEP) process, increased school-funded personalized opportunities, sports programs, and supplementary materials or opportunities for at-risk students without compromising personalized options. They also suggest varying curriculum ordering to ensure the Resource Center (RC) is stocked with items that meet students' preferences, proposing to start with a curriculum fair to gauge interest. These suggestions aim to enhance the overall experience at JCS and provide a wider range of opportunities for student engagement and success.

Concerns regarding the future of JCS include potential state restrictions, such as mandated daily synchronous meetings with Education Facilitators (EFs), which could lead to a loss of enrollment due to increased oversight. Additionally, there are worries about the impact of the charter moratorium and the need to protect approved charters from anti-charter agencies and agendas, especially considering criteria like test scores, test participation, and economic drain outlined in AB1505 Charter denial criteria. Furthermore, there are concerns that some JCS family initiatives may not be relevant for all JCS schools, potentially turning families off, highlighting the necessity for a better approval and filter process. These concerns emphasize the need for strategic planning and proactive measures to safeguard the future success of JCS-Pine Valley.

Two-Minute Conversation Campaign: Between January 2024 and April 2024, 106 responses were received from parents, students, and staff at JCS-Pine Valley when asked questions to elicit values, opinions, and information related to school improvement. According to the campaign responses, feedback from parents and students regarding their experience with JCS varies. Some students express positive sentiments about their schooling experience, citing improvements in their learning and enjoyment of certain aspects of education. However, others may express dislike for school or specific subjects, suggesting a need for more engaging or challenging classes. Parents generally appreciate the flexibility and support provided by JCS, noting their children's enthusiasm for learning from home or participating in enrichment activities. Suggestions for improvement include offering more diverse classes, such as home economics and music, as well as providing additional support for students who struggle with certain subjects like math. While many parents express satisfaction with the communication and support provided by JCS-Pine Valley, some suggest reducing automated messages and increasing focus on high school clubs and field trips. Overall, there is a mix of positive feedback and constructive suggestions aimed at enhancing the educational experience for students and families at JCS.

When asked about how the school should focus its LCFF dollars on school improvement, educational partners made recommendations for academic support and resources include expanding tutoring services, acquiring additional curriculum materials, providing supplies like notebooks and better computers, and upgrading technology. Physical facility improvements include constructing a gymnasium, expanding indoor facilities, installing playground equipment, and enhancing internet connectivity. Educational program enhancements focus on introducing interactive classes, expanding curriculum options, and implementing specialized teaching programs. Community and outreach improvements involve increasing field trips, hosting staff retreats, improving website communication, and investing in centralized facilities.

Overall, the suggestions aim to enrich the learning environment, support student development, and enhance the overall experience for both students and staff.

Feedback focused on improving post-secondary outcomes for students highlighted a strong desire for the integration of practical life skills and career preparation into the curriculum, with suggestions including tailored courses in financial literacy covering basic accounting, tax preparation, and credit management, as well as career exploration opportunities like job shadowing, Entrepreneur Week, and executive function life skills training. Additionally, they propose implementing home economics courses beyond cooking, teaching time management and essential life skills, and offering counseling support and a customized curriculum to meet individual student needs, highlighting the importance of preparing students for success in adulthood and the workforce.

Parent Feedback Survey: Parents express concerns about their children's academic progress, particularly noting a significant decline since expressing initial concerns at a parent-teacher conference. Despite efforts from both parents to support their daughter academically, including catching up on missing assignments and constant involvement, her grades have not significantly improved. The pace of learning is too fast for her, particularly in math, where despite the teacher's kindness and understanding, her grades remain low, raising concerns about the learning environment's suitability. Suggestions for improvement include providing opportunities for advanced students to be challenged, offering after-school activities, ensuring access to tutoring or specialized learning groups for students with Individualized Education Programs (IEPs), and promoting a wider range of extracurricular activities for better mental and social well-being. Additionally, for home study students, there is a concern about covering necessary topics, but collaboration with the Educational Facilitator (EF) helps address these worries effectively.

Parents advocate for improvements in the educational approach for their child, specifically in math, suggesting a spread-out curriculum throughout the year instead of being rushed into one semester. They express skepticism about standardized tests as accurate measures of their child's knowledge. Suggestions for enhanced support include more hands-on learning opportunities such as zoo and museum passes, a curriculum tailored more closely to individual student levels rather than California standards, and science classes with laboratory components. Additionally, they propose broader access to in-person events, programs, and extracurricular activities, including field trips, music, and sports, with funding options for multiple choices to foster social interaction and development. They also emphasize the importance of continued support for Educational Facilitators (EFs) and a diverse range of learning materials.

Parents highlight concerns about students feeling excluded and left out at school, suggesting that character-building initiatives could help address such issues. They emphasize the importance of communication, especially regarding sensitive topics like students experiencing suicidal ideations, expressing worry that some children may not be equipped to support friends in such situations. Despite overall satisfaction, they advocate for more in-person opportunities for social interaction and skill development through events, programs, and activities like field trips, music, and sports, to foster a sense of inclusion and enhance social-emotional wellness. They also suggest continuing to provide field trip opportunities as a means to connect and interact with other families.

Student Feedback Survey: Students express various desires for improvements at the school, including better socialization opportunities beyond field trips, additional options for math curriculum, more field trips for hands-on learning experiences, access to specific resources like slime, computer mice, and tutoring for students with Individualized Education Programs (IEPs). Suggestions also include adding elective courses such as computer programming, economic classes, and gardening, as well as enhancing support for college preparation and life skills. Other requests range from improved technology like Chromebooks, better handling of bullying situations, additional physical education

classes, and the addition of sports teams or facilities like volleyball courts. There are also calls for more diverse elective offerings, an emphasis on social, emotional, and ethical skills in education, and extended lunch times.

Students have shared additional requests for additional classes such as economics and cryptocurrency trading, improvements in studentteacher interaction and kindness, more frequent physical education classes or fun activities like field trips, and desires for larger class sizes and five-day weeks with transportation options. Some specific requests include longer lunch times, the addition of sports teams or activities, and more emphasis on early completion of required classes and graduation requirements. Additionally, there are suggestions for more engaging activities and events at school and general requests for improvements in various aspects of the educational experience.

Staff Feedback Survey: Staff express concerns about students' development and achievement, acknowledging the efforts of teachers while highlighting the need for a full-time counselor to address social-emotional learning (SEL) issues such as bullying. They suggest that a counselor could help mitigate these issues effectively. Additionally, they emphasize the importance of academic support for struggling students and opportunities for those who excel, suggesting tutoring supports and programs like GATE. Another concern relates to students' low reading levels and parents' lack of follow-through with suggested interventions, with the suggestion of utilizing the Student Study Team (SST) process as a solution.

Staff members suggest improvements for various subject areas at JCS-PV. They commend the school's efforts but propose enhancements such as more current and accessible textbooks through the Resource Center (RC) for science and social studies, along with increased lab opportunities for all grades. Additionally, they advocate for more in-house tutoring services for ELA and math and emphasize the need for structured lesson plans and activities to assist parents in guiding students through physical education (PE) classes. Furthermore, they highlight the importance of fostering student engagement and suggest providing standard-based curricula tailored for home study students as a means to improve achievement in all subjects.

Staff offer suggestions for improving the school's support for students' social-emotional wellness, emphasizing the need for consistent access to a counselor on campus daily. They also propose the provision of a specialized teacher or staff member to teach coping skills and maintain regular communication with parents and students. Additionally, they stress the importance of the school showing genuine care for students and parents and providing them with tools to navigate challenging situations effectively.

The LEA has internalized this feedback and embraced it within the development of the 2024/2025 Local Control Accountability Plan. The goals included in this LCAP are aligned to the state priorities and a majority of the metrics are required but the actions and services are inspired by our educational partners.

Feedback from partners suggests that students, parents, and staff generally express positive sentiments about JCS-Pine Valley citing small class sizes, supportive teachers, and the opportunity to improve academically with access to educational materials and curriculum choices. To ensure staff are trained and well supported, the LEA will take action to provide a funded induction program for new teachers and administrators who need to clear their credentials. The instructional materials provided by the school are paramount to student success; therefore, we will ensure they are accessible to all students, rigorous, and aligned to standards through actions related to curriculum analysis, adoption, and implementation, technology provisions and support, and programs and services for unrepresented students. We will ensure that the facilities are safe for individuals by assessing physical spaces on campuses and ensuring janitorial services, necessary repairs, and building improvements. Within the metrics, actions, and services below, we aim to maintain many basic services through tracking systems while attending to improvements in curriculum, resources, and facilities for all students and support services for students with special needs.

Based on the school's Academic Performance and College and Career Readiness Indicators on the 2023 CA Dashboard, as well as partner input, we've determined the school needs to dedicate resources, time, and attention to providing high-quality, equitable, and responsive instruction so all students can succeed at high levels. Declining achievement in ELA and Math at the end of the last LCAP cycle indicates that all students must continue increasing communication and critical thinking skills. This is especially important for SwDs who have lower performance levels on the CA School Dashboard. Although 2023 academic data for English Learners is not publically available due to data suppression and low student numbers, an internal analysis of raw data files tells us that ELs are also performaning far below all students in ELA and Math; therefore, we intend to address this equity gap with contributing actions/services. Additionally, secondary students need increased opportunities to be prepared for life after graduation and considered College and Career Ready including a-g course access, dual enrollment, and career-technical education (CTE) opportunities. Through a lens of equity, the school will focus on the needs of ALL students ensuring significant subgroups and unduplicated groups have comparable student outcomes. This includes the school's ability to support English Learners on their path to becoming fluent English proficient. We will monitor growth and make instructional decisions to impact achievement in differentiated areas of need throughout the school year using the NWEA MAP assessment. The identified metrics below will help us measure growth and tell us if the actions/services identified are making an impact and enabling us to address areas of student need authentically.

An explanation of why the LEA has developed this goal.

Feedback from stakeholders shows that overall our students and parents feel connected to and supported by their teachers and that the school provides a safe and nurturing environment. An analysis of data from the state and some local tools such as our school information system affirms this, demonstrating low and equitable suspension, expulsion, and drop-out rates for all students. Even so, on the Holistic Student Assessment (HSA), we have seen the % of students placed in Tier 3 (most significant SEL needs) increase dramatically from 16% in 2020 to 35.6% in 2023. Among SwD, 45.5% are Tier 3 for SEL support. We hope to address the SEL needs of our students with the Leader in Me leadership program and PBIS. The Chronic Absenteeism rate has been on the rise over the last 3 years and while JCS-Pine Valley's chronic absenteeism rate is far below the state's and the county's, SED students are chronically absent 3% more than the overall student population at JCS-PV. We also need to focus on increasing participation in family engagement activities that we host at our locations and decision-making opportunities such as surveys, School Site Council meetings, and board meetings. On a parent survey given in Spring 2024, we received 19 responses, representing approximately 11% of our parent population. Of those responses, only one was the parents of an EL student, one was a parent of a SwD, and none were parents of SED or FHY students. Through the actions and services below, we hope to increase parent involvement, student engagement, and the overall school climate at JCS-Pine Valley.

- This amount is the total of the Estimated Actual Expenditures for Contributing Actions (LCFF Funds).

 - This amount is the Total Estimated Actual Expenditures for Contributing Actions (7) subtracted from the Total Planned Contributing Expenditures (4).
- 5. Total Planned Percentage of Improved Services (%)
 - This amount is the total of the Planned Percentage of Improved Services column.
- 8. Total Estimated Actual Percentage of Improved Services (%)
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).
