



MWEA MAP Fall to Winter Growth (Reading)



- Reading growth is slightly below average: Median growth is at the 46th percentile, with 43% of students below the 41st percentile, indicating many students are not making accelerated progress.
- Achievement remains above average but dipped slightly: Median achievement decreased from the 60th percentile (Fall) to the 58th percentile (Winter), suggesting mild regression or plateauing.
- Large, stable sample shows systemic trend: With 144 students, the consistent pattern points to a schoolwide need to strengthen reading growth, not isolated cohort issues.

NWEA MAP Fall to Winter Growth (Math)



- Overall growth is below average: Median growth is at the 44th percentile, with nearly 47% of students below the 41st percentile, indicating slower-than-expected progress across grades.
- Achievement declined from Fall to Winter: Median achievement dropped from the 60th percentile (Fall) to the 53rd percentile (Winter), with fewer students in the top performance bands.
- Large sample, consistent pattern: With 140 students, the results are stable and suggest a systemic need to strengthen instructional growth, rather than isolated grade-level issues.


