

LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).




This chart shows the total general purpose revenue JCS-Manzanita, San Diego County Office of Education expects to receive in the coming year from all sources.

The total revenue projected for JCS-Manzanita, San Diego County Office of Education is \$3,488,981, of which \$2,702,736 is Local Control Funding Formula (LCFF), \$0 is other state funds, \$786,245 is local funds, and \$0 is federal funds. Of the \$2,702,736 in LCFF Funds, \$159,498 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.



This chart provides a quick summary of how much JCS-Manzanita, San Diego County Office of Education plans to spend for 2019-20. It shows how much of the total is tied to planned actions and services in the LCAP.

JCS-Manzanita, San Diego County Office of Education plans to spend \$3,319,016 for the 2019-20 school year. Of that amount, \$184702.04 is tied to actions/services in the LCAP and \$3,134,313.96 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

Classified and certificated benefits, most staff salaries, facilities and facility related expenses.


#### Increased or Improved Services for High Needs Students in 2019-20

In 2019-20, JCS-Manzanita, San Diego County Office of Education is projecting it will receive \$159,498 based on the enrollment of foster youth, English learner, and low-income students. JCS-Manzanita, San Diego County Office of Education must demonstrate the planned actions and services will increase or improve services for high needs students compared to the services all students receive in proportion to the increased funding it receives for high needs students. In the LCAP, JCS-Manzanita, San Diego County Office of Education plans to spend \$7854.08 on actions to meet this requirement.

The additional improved services described in the LCAP include the following: Coordinator will oversee implementation of curriculum for ELs and will work with staff to ensure Foster/Homeless Youth and Low Income students have services needed.

Update on Increased or Improved Services for High Needs Students in 2018-19



This chart compares what JCS-Manzanita, San Diego County Office of Education budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what JCS-Manzanita, San Diego County Office of Education estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

In 2018-19, JCS-Manzanita, San Diego County Office of Education's LCAP budgeted \$25,000 for planned actions to increase or improve services for high needs students. JCS-Manzanita, San Diego County Office of Education estimates that it will actually spend \$7107.21 for actions to increase or improve services for high needs students in 2018-19.

The difference between the budgeted and actual expenditures of \$-17,892.79 had the following impact on JCS-Manzanita, San Diego County Office of Education's ability to increase or improve services for high needs students:
