# **Community Engagement**

Our proposed ESSER III plan was developed based on previously identified school needs through the Expanded Learning Opportunities Plan (ELO Plan) and LCAP process. The administrative team - comprised of our Executive Director, Principal, Assistant Principal, Director of Special Education, Director of Assessment, Accountability & Compliance and fiscal team - identified priorities that were not able to be funded from other funding sources and ranked those priorities based on needs identified in the current school year. The team also reviewed our demographic data to determine who our stakeholders and community groups are. Our school does not have a local bargaining unit, nor are any civil rights agencies involved with any of our students. Our English learner population is less than 10 families and based on previous feedback and interactions with them, we feel confident that our communications in English are sufficient for their needs. In addition to parents, students, teachers and other certificated staff, administration, and classified staff we determined we needed to gather input from our

SELPA and the local tribes that potentially serve our Native American students. On 10/13/21 an email was sent via website to our SELPA (El Dorado), who represent our students with disabilities and on 10/22/21 an email was sent to both the Pechanga and Cahuilla tribal nations, who represent some of our Native American students, to review highlights of our proposed plan and gather feedback and suggestions on areas of concern they see with the student and family populations they serve. A link to our survey was sent to all three parties and they were encouraged to contact us directly to provide additional feedback.

On 10/18/21 (6:00pm) and 10/20/21 (12:30pm) we held virtual feedback sessions via Zoom for parents, students, and all staff - teachers and other certificated staff as well as all classified staff (paraprofessionals, office staff) - and sent a survey on 10/18/21. We selected a times that would be more convenient for parents in the evening, as well as a day time meeting for hourly staff to attend during working hours. Our school community received multiple email reminders with the the links to the Zoom class and survey as well as an email address for providing feedback. During the live feedback sessions we reviewed our proposed plan and gave access to attendees to provide comments and suggestions on our proposed plan. The meeting was recorded and sent via email to our entire school community to watch the recording at a time and location that was accessible for them. Those watching the recording were able to provide feedback on the plan through email or survey. The plan was submitted to our governing board on October 29th for review, discussion, and approval.

#### A description of how the development of the plan was influenced by community input.

65 people responded to the survey. 59% were parents, 26% were students 15% were staff. Three JCS-Pine Hills parents emailed their feedback, and one staff member watched the Zoom recording and emailed feedback. On the survey parent and staff respondents indicated the their greatest areas of concern are math (34%), the social/emotional impact of COVID (28%), and Language Arts (24%). Student respondents overwhelmingly indicated that College/Career Readiness was their greatest area of need. Respondents indicated that they felt the greatest impact for lost instructional time would come from additional tutoring sessions (52%), additional staff (42%), and smaller class sizes/EF rosters (27%), with the majority of students indicating additional staff or smaller class sizes. On the open-ended question respondents indicated that they would like more opportunities for students to connect with peers and have more experiential learning (i.e. field trips) and electives to help students re-engage. Parents of students with disabilities also see the need for additional support at school as well as peer interaction opportunities.

JCS-Pine Hills's ESSER III plan will include greater support for students with disabilities, which comes from parent input. Staff, students and parents all feel that the smaller classes/rosters will help the students. Students indicated they want more support for College/Career Readiness, including more access to the school counselor. Using ESSER III funds we'll be able to pay for our school counselor and assistant principal, which will free up other funding sources to keep our class sizes and EF rosters smaller for the next two years and to allow for more field trips and other experiential learning activities parents are looking for.

# **ESSER III Expenditure Plan Instructions**

#### Introduction
