Statewide Assessments

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. JCS-Cedar Cove hosts professional development days throughout the school year, approximately every eight weeks with additional days at the beginning of the year. Teachers also have a Professional Development week at the beginning of semester 2 during which all students have a Project Week. For 2021-2022 the Professional Development focused on Outdoor Learning and Social Emotional Learning. Our forums focus primarily on school policy, student achievement, curriculum, teaching and learning strategies, technology support and training, and self-selected professional learning communities. Teachers new to the profession and new to independent study receive support through mentoring opportunities.
