The following is the local educational agency's (LEA's) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

## **Plan Descriptions**

A description of how parents, teachers, and school staff were involved in the development of the plan.

All parents/legal guardians with currently enrolled students were surveyed to determine where they felt the most need is for their child. 82 parents responded. Respondents represent a balanced sampling of our school, with approximately 1/3 each representing homestudy, PH academy K-8 and PH academy 6-12 and INSITE. Parents reported these in order of most importance:

- Additional/expanded supports to close learning gaps (66%)
- Supports for credit deficient students to meet graduation requirements (26%)
- Extended instructional learning time (22%)
- Additional supports to address other barriers to learning (22%)
- Community learning hubs (13%)

Teachers and school staff were also surveyed to determine what strategies and supports were most needed. 34 staff members responded (also about 1/3 each of our three main programs along with INSITE) and reported these in order of most importance:

- Additional/expanded supports to close learning gaps (91%)
- Supports for credit deficient students to meet graduation requirements (41%)
- Additional supports to address other barriers to learning (41%)
- Community learning hubs (27%)
- Extended instructional learning time (18%)

Staff members identified these as the 4 areas for which they feel they need training the most: 1) addressing learning loss; 2) identifying gaps in learning; 3) supporting students with IEPs; and 4) social emotional learning.

Two input meetings for staff were held to discuss strategies the school could use. Feedback was solicited when the draft plan was presented to School Site Council and in a staff newsletter.

These assessments tools will be used to screen students:

Grades K-1: Kindergarten Skills Inventory

Grades 1-6: DIBELS

Grades 2-12: NWEA MAP 2-3x year for reading and math

Grades K-12: Benchmark assessments for math

English Learners: any of the above that applicable based on grade level as well as ELPAC and SOLOM

Students with Disabilities: any of the above that are applicable based on grade level as well as informal measures related to IEP goals Social emotional: Holistic Student Assessment (HSA)

Students identified as being below standard will also be given Dibels/DAZE to determine the types of academic intervention, if any, are needed and to monitor progress in intervention. HSA results will be used to determine any types of social/emotional intervention that may be needed.

Parents will be notified of schoolwide plans via ParentSquare in English and Spanish. Students who are identified for targeted instruction will receive individualized communication, translated as needed.

A description of the LEA's plan to provide supplemental instruction and support.

The school will focus the funds in three major areas outlined below:

Integrated Community Supports

A team composed of a designated community liaison, a counselor, and school secretaries will work to build our community by creating a safe, resourceful space, organizing social opportunities and facilitating events. Some details could include:

- Community Space with Tech, Supplies, books etc
- SEL Groups in the Community Space (i.e., game group, or social group)
- Workshops and evening events for families (i.e, Math Night)
- Mentorship/Tutoring Programs
- Increased educational and engaging field trips

### **Expanded Learning Opportunities**

A team composed of a designated staff member and teachers will extend our academic programs and services. Some details could include:

- Summer programs
- Special Education and Tier 2 Intervention services provided through the summer
- Increased PE, VAPA and/or STEM throughout the year
- After school or before school programs.

#### **Learning Acceleration Program**

A team composed of the coordinators, a designated educational facilitator, and counselor will increase the school's capacity to address learning loss and accelerate learning. Some details could include:

- Increased number of Instructional Aides in academy and home study programs.
- Professional Learning program for aides and teachers to include targeting learning loss, supporting students with exceptional needs, data and assessment, and social and emotional learning
- Additional programs to target learning loss (i.e. FastForWord, Orton-Gillingham, Read Live)
- Additional supports for assessing and monitoring student progress
- Systematic schedules to maximize increased staff and learning programs

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Title II ESSER funds will be identified with goals, actions and services in our LCAP and aligned with the ELO Grant Plan. As a part of our ELO funds, we will implement a Learning Acceleration Program (detailed in the Plan Description section). To supplement the Learning Acceleration Program, we will use ESSR funds to address the unique needs of low-income students, children with disabilities, English learners, racial and ethnic minorities, students experiencing homelessness, and foster care youth, by lowering the student to teacher ratio in our home study program. The lower student to teacher ratio will also ensure the adequate capacity of teaching staff to address learning loss and assess and monitor progress amongst these same student groups.

## **Expanded Learning Opportunities Grant Plan Instructions: Introduction**

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code* (*EC*) Section 43521(b). ## **Instructions: Plan Requirements**

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

### For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

#### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
