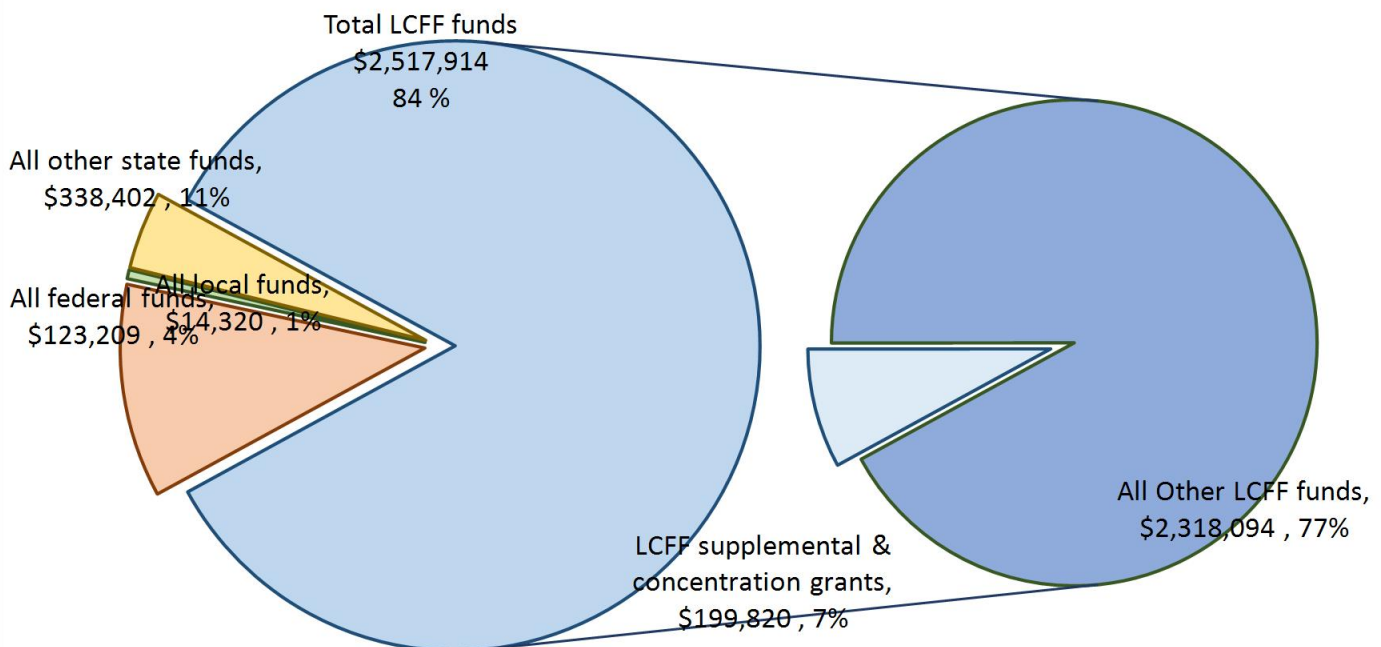

Projected Revenue by Fund Source

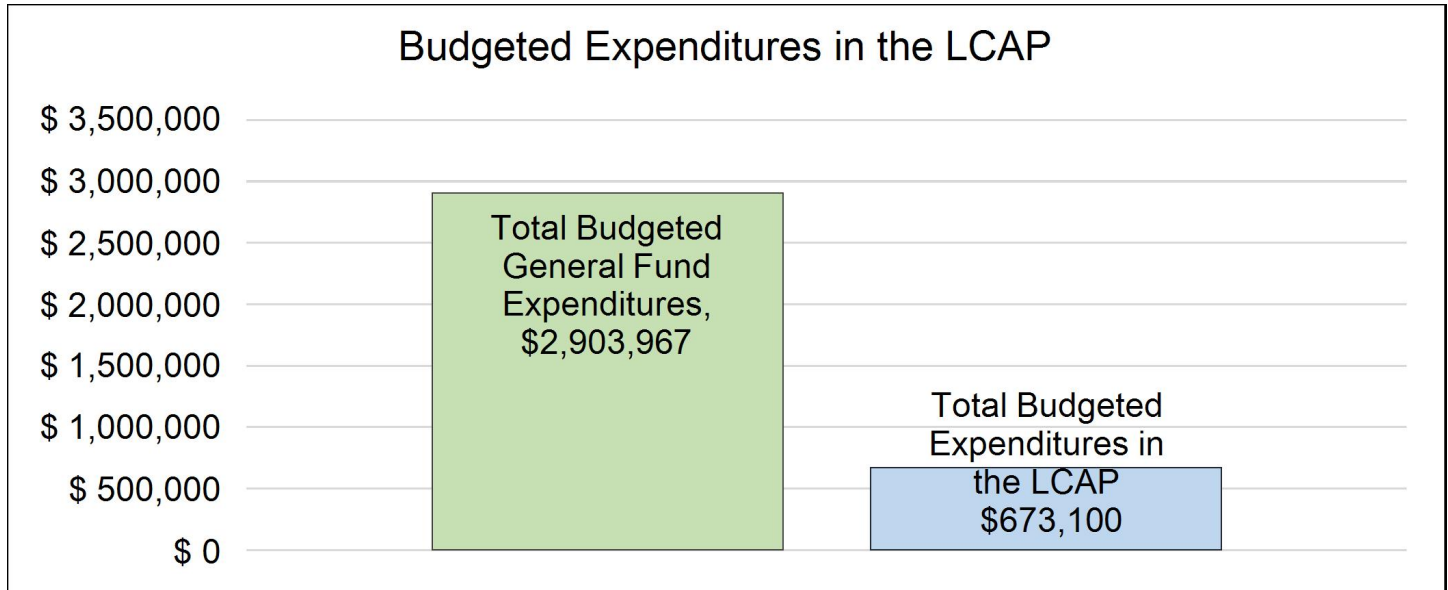


This chart shows the total general purpose revenue Julian Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Julian Charter School is \$2,993,845, of which \$2,517,914 is Local Control Funding Formula (LCFF), \$338,402 is other state funds, \$14,320 is local funds, and \$123,209 is federal funds. Of the \$2,517,914 in LCFF Funds, \$199,820 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

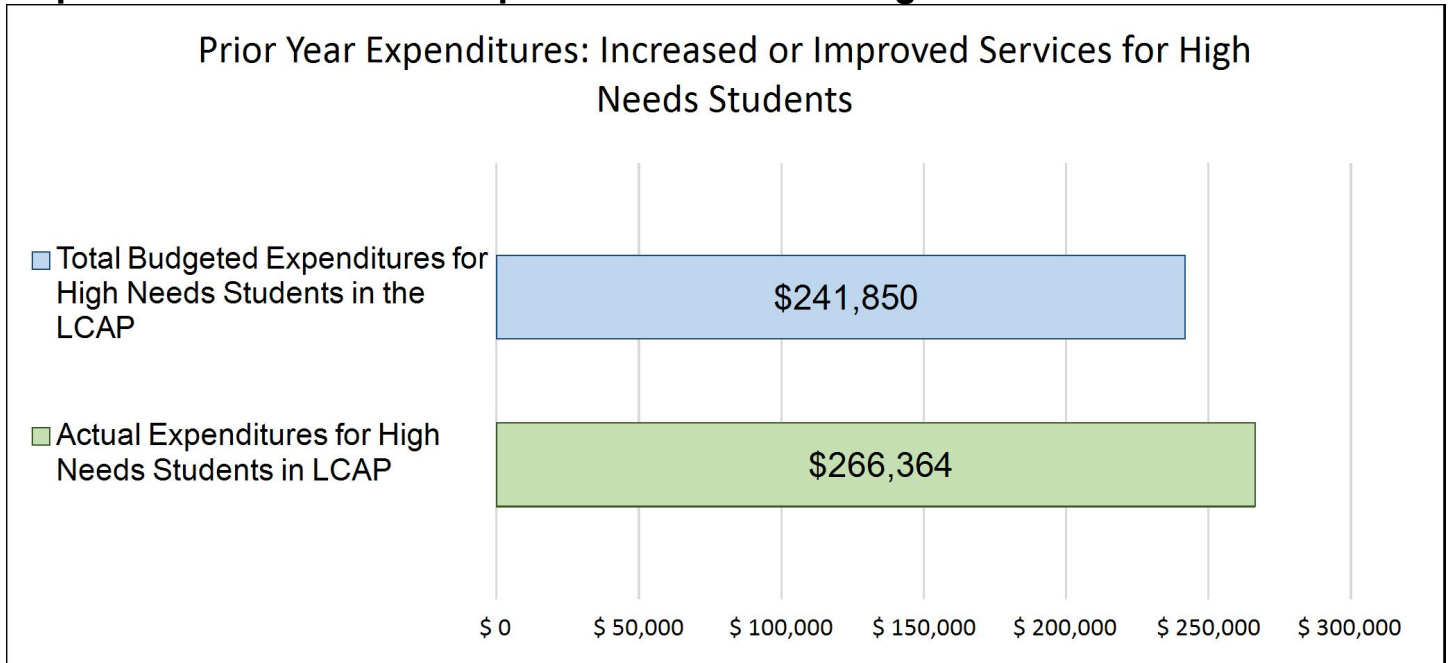
The LCAP is written as a focus goal plan for school improvement. It has been developed based on needs identified through data analysis and partner impact. Basic operational costs, such as general education salaries/benefits, are general fund budget expenditures that are not included in the LCAP.

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Julian Charter School is projecting it will receive \$199,820 based on the enrollment of foster youth, English learner, and low-income students. Julian Charter School must describe how it intends to increase or improve services for high needs students in the LCAP. Julian Charter School plans to spend \$285,600 towards meeting this requirement, as described in the LCAP.

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

- 1.4 - In addition to supporting clear-credential programs for new teachers, we also supported a clear-credential program for a new administrator.
- 1.8 - Along with all listed MTSS actions, we also purchased the Beyond SST program and received training to use it for managing and monitoring MTSS plans.
- 1.17 - To support Learning Loss (and in addition to Summer School), we added 3 part-time paraprofessionals during the instructional year.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

- 1.3 - We were over budget for Internet & Instructional Materials for Socioeconomically disadvantaged (SED) students and Foster/Homeless Youth (FHY). in 23/24, 45% of our student population was SED and we provided hotspots to ensure they had access to reliable internet. This resulted in more expenditures than budgeted but the action was carried out as planned.
- 1.4 - We were over budget for the PD-Induction action. We paid for three teachers to clear their teaching credentials and one administrator to clear her admin credential.
- 1.5 - We were 17% over budget for Math Support. We carried out this action as planned, providing a paraprofessional to support our math instruction and the total cost of this action/service was slightly more than projected.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

The most important metric for measuring progress toward Goal #1 (students achieve at high academic levels in Language Arts and Math) was the DFS for ELA and Math (CAASPP) and, over the course of the 3-year LCAP cycle, students made significant growth. We are proud that, as a school, our distance from the standard has increased beyond our desired outcomes for all students and most student subgroups. We were also successful in reducing the % of 9th graders enrolled in Transitional Math. Specific actions that were effective in attaining these outcomes include the continued use of CCSS-aligned online curriculums such as Edgenuity and Schools PLP, Professional Development for staff, and MTSS actions. The only student subgroup that did not meet the DFS desired outcome was Low-Income students in Math. It is important to note that the data shows our SwD students need continued support in Math and ELA achievement and LI students need support in Math, as demonstrated through significant equity gaps. This will be addressed with contributing actions and services in the 24/25 LCAP.

Our EL Coordinator and FHY Liaison continue to build authentic relationships with their prospective student subgroups and support the quality of services received. We provided ongoing focus groups/surveys for EL and SwD parent involvement and feedback to inform curriculum, programming and supports and 100% of SwD and EL parents rated that they felt "highly supported" on a likert scale. We did not

meet our desired outcomes for EL reclassification and ELPI level increase in 2023 but we recognize that our EL population is very small and can fluctuate greatly from year to year as a result.

24/25 introduces a new LCAP with new 3-year goals, metrics, desired outcomes, and actions. In the new LCAP, we have categorized the 8 state priorities and written 3 broad goals in the areas of Conditions of Learning, Student Outcomes, and Engagement. This approach has resulted in a reorganization of metrics and actions. For instance, actions related to accessing curriculum and materials are basic services in the new Conditions of Learning goal. Actions related to student performance on CAASPP, CAST, and MAP are in the Student Outcomes goal.

In the new LCAP, we are not including a metric for 9th graders enrolled in transitional math as we believe our actions and services have been effective in reducing this. We will also shift our focus on MAP data to primarily measuring growth over Fall, Winter, and Spring testing windows within a single school year and rely on CAASPP to provide an accurate reflection of student achievement. As we continue to focus on our MTSS program in the 24/25 LCAP, we plan to identify RTI metrics for students in grades TK-1 so we can measure and report their progress. Additionally, we have begun to implement the Beyond SST program to bring improved consistency, structure, and accountability to our MTSS program and this will be a new action in the 24/25 LCAP.

2.2 - We did not provide a SEL counsellor as planned but our academic counselor was able to assist with the individualized SEL needs of students.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

2.1 - We are 67% over budget for the Social Emotional Needs goal due to underestimating the annual costs for the Holistic Student Assessment and Security.
 2.2 - We are 86% under budget for the SEL Counsellor action because we did not hire an SEL Counselor due to a lack of funding within our annual school budget.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Our actions were effective in reducing the percentage of students placed in the Tier 3 (crisis) level on the Holistic Student Assessment and we met our desired outcome for this metric. We did develop partnerships with community organizations and parents to address learners' social and emotional needs (SEL) at JCS-Live, as evidence through the development of an SEL resource directory for students and their families.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

A deeper dive of our HSA results revealed equity gaps within some student subgroups. For instance SED, SwD, and Hispanic students had higher percentages of Tier 3 students. Additionally, SED students have the lowest percentage of Tier 1 students (29.4%) with the lowest number of average strengths and the highest number of average challenges. Assertiveness is the most significant challenge among several student subgroups and overall. In 2024/2025 LCAP, the school is addressing this within Goal 3 and the "Leader In Me" action. With the Leader in Me program, the school will implement an evidence-based model focused on leadership, culture, and academics that equips students, educators, and families with essential leadership and life skills, preparing them to excel. This includes staff training, curriculum materials, and teaching/learning resources.

A description of any substantive differences in planned actions and actual implementation of these actions.

3.1 - Our school, is Increase student access to CTE pathways by providing Career Technical Education curriculum through Edgenuity but we have not supported costs for current staff who would like to get CTE certification because no staff members have expressed interest in this.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

3.1 - We are under budget for CTE pathways because we have not paid for any staff to get CTE certification.
3.7 - We overestimated the budget for CTE pathways and only spent about half. This action was carried out as planned.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

It is our goal to prepare students for the world of work and, according to SIS data, 21% of our 23/24 graduating seniors were College and Career Ready. This is due to one of three criteria: 1) Completed 2-semesters with a C- or better in college credits, 2) Met UC/CSU a-g course requirements plus, Level 3 or Higher score on the state test in ELA or Math, and level 2 in the other subject and 3) Standard Met or Higher Smarter Balanced score in ELA and Math. We met our desired outcome for the Specific actions the "% of students completing college credit course" metric and the specific action that supported this success was action 3.8 (College Credit Course Access). We also met our desired outcome for the graduation rate, largely attributed to action 3.6 (High School Counsellor). Additionally, our Bound for Blue program continues to promote and incentivize students to complete milestones and the path to becoming College and Career Ready

We did not meet our desired outcome for a-g completion even though action 3.7 aimed to support growth aligned to this metric. We added electives and continue to utilize the Edgenuity course catalog to offer a wide range of a-g approved courses. In the future, we will consider having our high school counselor conduct a need assessment to determine why our actions have not been successful in increasing the percentage of students who complete a-g requirements.

We increased access to CTE pathways but 0% of students completed a CTE pathway in 2023/2024. We will continue to promote CTE courses offered by Edgenuity and ensure our high school counselor is discussing this CCR criteria with students when developing 4-year plans for high school students.

We are proud to have established an internship program in 23/24 and look forward to growing it and having more students engaged in internships, job shadows, and work study.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

College and Career Readiness and our school's CCI performance on the CA Dashboard is a priority for our school; therefore, many of these metrics and actions will be continued in the 24/25 LCAP appearing primarily in Goal #2 (Student Outcomes) and Goal #3 (Engagement). We will continue to increase a-g, dual enrollment, and CTE course access in the new 24-27 LCAP cycle. We would like to see our a-g completion rate increase and will conduct a needs assessment to determine why our actions have not been successful. At this time, JCS-LIVE does not intend to invest resources in promoting access to AP courses.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

This was a maintenance goal and all actions were successful in maintaining the baseline. According to the metrics, our school effectively maintains an engaging, safe, clean, and healthy learning environment for our students. We have almost all of our desired outcomes, with the exception of Chronic Absenteeism rate. Since 2021 and COVID, Chronic Absenteeism rates have been high throughout the state and JCS-Live has been successful at reducing chronic absenteeism since 2021 but it is still much higher than the desired outcome set before COVID. General Information

Julian Charter School (JCS-LIVE) is an independent study TK-12 charter school sponsored by the Julian Union Elementary School District. JCS currently serves approximately 200 students from San Diego, Orange, and Riverside counties. Julian Union, a small district in San Diego County, founded JCS in November 1999 to meet the needs of students underserved by traditional systems and for families with a strong desire to home school. JCS grew to serve over 2500 students over the years with homestudy and hybrid independent study options. Due to a change in independent study law in 2018, JCS had to re-group and split into six different charter schools.

Today JCS-LIVE is a synchronous online school, where all students and teachers meet virtually. The main JCS office is located at the Julian Union district's middle school campus, which houses a small number of back office staff.

The mission of JCS-LIVE is to provide an alternative classroom setting tailored for students who desire a synchronous, online, personalized environment focused on Career and Technical Education. We are dedicated to excellence and committed to nurturing passionate lifelong learners. Core values include:

- Creativity and Innovation: Envision and explore rich teaching and learning opportunities.
- Commitment: Educate students to their full potential and uphold the greater good of the school.
- Choice: Empower individual paths and goals through personalized learning.

- Excellence: Foster a climate of high expectations, quality, and accountability.
- Integrity and Compassion: Model honesty, dignity, fairness, and responsibility while demonstrating respect and understanding.

JCS-LIVE teachers and staff are committed to helping every student achieve and succeed. Educators inspire and empower students to reach their goals. Students feel a sense of community and support even though they are working from home. Students interact with teachers and have opportunities to interact with peers as well. Our goal at JCS-LIVE is to build skills and develop a love for learning and develop the foundation for life success. We utilize vetted and personalized curriculum designed to build skills and interest in all of our students. Students receive kits each month filled with activities and individualized items to make learning fun.

In the 23/24 school year, JCS-LIVE supported approximately 193 learners in grades TK-12. Our student population consists primarily of white students (56.5%) and hispanic students (40.4%). Our special education population is large in comparison to most districts (27.5%) although this is due in part to our small total population. Due to the nature of independent study, our English language learner population is small (only 3.0%), since for at least a portion of the week the parent is the teacher for the student. Our socioeconomically disadvantaged population is 45.41%, and our homeless and foster youth make up 3.5% of the population. While we don't have a migrant population in the traditional sense, we do have a somewhat transient population: Some families decide that home study is not the right "fit" for them, while others move back and forth between different charter schools looking for different resources and schedules.

Students come to JCS-LIVE for various reasons: some are looking for an option other than their local school because they aren't happy with what their local school has to offer while others prefer the traditional home study model with the flexibility and choice in curriculum and daily schedule. Because our school covers such a large geographical area, our student demographics and needs vary somewhat depending on the region. As a school we look at data by county and grade level (TK-8 and 9-12) and as a whole to identify our students' needs. While JCS LIVE strives to support all learners in meeting their potential, we are very aware of our struggling and at-risk learners and their diverse needs and are constantly striving to provide additional supports.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The 2023 CA School Dashboard was released in December 2023 and revealed areas of academic performance and engagement where Julian Charter School aka JCS-LIVE is improving or declining. This information allows us to reflect on the effectiveness of actions/services in the 23/24 LCAP and emphasizes areas where JCS-LIVE should focus actions/services in the 24/25 LCAP, especially related to equity for disadvantaged subgroups of students. For a number of engagement indicators and state-required metrics, data is not publicly available for JCS-LIVE students due to small enrollment numbers; therefore, we used local data and calculations to determine overall performance and equity gaps.

ELA Performance Analysis: Overall, 58.97% of all JCS-LIVE students met/exceeded the standard in ELA on the 2023 CAASPP. According to the CA Schools Dashboard, Distance from Standard (DFS) is 17 points above standard, an increase of 11 points from the 2022 ELA CAASPP performance. This has placed JCS-LIVE in the "green" performance category. JCS-LIVE's achievement on the ELA performance indicator is higher than the state and we are proud of this growth!

From an equity lens, our socio-economically disadvantaged (SED) and Hispanic populations perform on par or just slightly below the overall population, indicating that our actions/services in the 23/24 LCAP have helped to close the equity gaps for these groups. The equity gap between Students with Disabilities (SwD) and non-SwD is still significant though: -31.3. Only 34.62% of the SwD population met/exceeded the standard in ELA in 2023. Moving forward and planning for our 24/25 LCAP, we will identify specific actions/services to close the SwD equity gaps.

Math Performance Analysis: According to the CA Schools Dashboard, JCS-LIVE students performed slightly lower than the state in Math on the 2023 CAASPP and placed in the “orange” performance category due to a DFS of 36.1 points below standard, a decline of 3.3 from 2022. 32.46% of all JCS-LIVE students met/exceeded the standard in Math on the 2023 CAASPP. Socio-economically disadvantaged (SED) students and Students with Disabilities (SwD) performed significantly lower in Math than the overall population with equity gaps of -19.0 for SED students and -26.9 for SwD. Hispanic students had an equity gap of +3.8 since they performed higher than the overall population with 35% of all Hispanic students meeting/exceeding standards in Math.

CAST Performance Analysis: JCS-LIVE’s overall performance on the CAST shows that 39.68% of students met/exceeded science standards, which is on higher than the county and the state. Similar to Math, significant equity gaps are present for SwD and SED subgroups. 33.33% of SED students met/exceeded the standard and 14.29% of SwD met/exceeded the standard. Hispanic students also achieved below the overall student population who took the CAST last year with 30% of Hispanic students meeting/exceeding science standards.

EAP Performance Analysis: In 2023, JCS-Manzanita’s population of 11th-grade students outperformed the state and county’s EAP College Ready Rate in ELA with 31.25% meeting/exceeding the standard on the CAASPP. Our significant subgroups performed as high or better than the overall population of 11th graders. 41.67% of SED students, 50% of SwD, and 38.46% of Hispanic students met/exceeded the standards in ELA.

11th-grade students did not perform as well in Math as they did in ELA in 2023. Overall, JCS-LIVE students performed below the state with 6.3% of JCS-Live students meeting/exceeding standards in Math compared to the state’s 12%. Additionally, 0% of SED students met the standard. SwD and Hispanic students performed higher than the overall JCS-LIVE student population and higher than their subsequent populations at the state and county levels.

EL Performance Analysis: Due to small student numbers, no public data is available for JCS-LIVE related to the ELPAC Reclassification Rate. Internal data and calculations tell us that we were unable to reclassify any students based on their Spring 2023 ELPAC performance and other criteria related to reclassification. Similarly, 0% of our very small population of EL students improved one ELPI level from Spring 2022 to Spring 2023 on the summative ELPAC. As our EL numbers increase, we will focus more efforts on improving EL rates of development and reclassification by analyzing the effectiveness of current actions/services and increasing them.

In 2023-2024, we started using a new online ELD curriculum, SummitK12, for all students in grades K-3 and students in grades 4-12 with a Level 1 or 2 ELPAC score. EL Students in grades 4-12 with a Level 3 ELPAC score continued to use Achieve3000, another fully online curriculum. In addition to completing personalized ELD assignments with the online curriculum, all students met regularly with the school's

designated EL teacher for speaking/listening activities. Students who participated regularly made significant gains in their Lexile scores and benefitted greatly from the additional interactions with a teacher. As our EL population grows, we hope this shift in ELD curriculum programming and the increased opportunities to engage in synchronous listening/speaking instruction with the ELD teacher will result in RFEP and ELPI improvement rates.

The only student engagement indicators that populated the 2023 CA Schools Dashboard for JCS-LIVE were Chronic Absenteeism and Suspension Rate. JCS-LIVE was placed in the “yellow” (or middle) performance level for status and change on the Chronic Absenteeism indicator on the 2023 CA Schools Dashboard. Our Chronic Absenteeism DFS for all students is 12.1%. Additionally, our SED subgroup was placed in the “red” or lowest performance category, requiring a specific action/service for improvement in the 24/25 LCAP. According to the 2023 CA Schools Dashboard, 22.2% of SEDs are chronically absent which is 5.6% increase from 2022.

JCS-LIVE is proud to have maintained 0% suspension and expulsion rates in 2023 for all students and subgroups. We will continue to promote strong SEL and leadership programs that increase student engagement and support behavior interventions.

In 2023, 17% of JCS-LIVE students met A-G Completion status. This does not meet our desired outcome, despite actions/services to increase the a-g completion rate. We will re-evaluate our efforts and seek to implement new and improved actions/services related to a-g completion. Additionally, we acknowledge that ensuring our graduating students are College and career-ready is a priority for JCS-LIVE and, in the last LCAP, our dominant strategy was to improve access to dual enrollment opportunities and support students to pass at least 2 community college courses.

The 2023 drop-out rate for JCS-LIVE is not publicly available due to small student numbers but internal data tracking tells us that our 2023 drop-out rate was 0%. Additionally, the 2023 Graduation Rate for JCS-LIVE was 92%. Both these outcomes are more desirable than the state and San Diego County.

We administered the Holistic Student Assessment (HSA) to 148 students in 3-12th grade in Fall 2023 and observed that the % of students placed in Tier 3 (most significant SEL needs) has decreased from 22% in 2022 to 18% in 2023. This was our desired outcome. Further analysis of HSA revealed that empathy was a strength overall and the most common challenges for JCS-LIVE students were Assertiveness and Action Orientation. From the results of the HSA, it is clear that Socioeconomically disadvantaged students (SED) need the most significant SEL support. SED students have the lowest percentage of Tier 1 students (29.4%) with the lowest number of average strengths and the highest number of average challenges. This indicates an increased need to support SED students with SEL programs and professionals. In 2024, we hope to address the SEL needs of all our students with the Leader in Me leadership program.

The 2023/2024 school year also introduced the Beyond SST program to bring more structure, consistency, and accountability to our MTSS efforts. The Beyond SST roll-out and subsequent professional training have allowed the school to continue working with teachers on clarifying processes and support available to students while holding more routine SST meetings, implementing research-based intervention, and monitoring progress. As a school, we continue to emphasize the importance of participation in local common benchmark assessments to obtain valid growth data and identify students in need of tiered support.

Since this has been an LCAP development year and the LEA was challenged with writing new goals for focused school improvement over the course of the next 3 years, we sought to develop a comprehensive plan for getting partner input. This included structured group forums/discussions around school improvement needs at the School Site Council meetings in January and May 2024, a two-minute conversation campaign (2MC) encouraging staff to gather direct, synchronous feedback to a "Question of the Month" as they interacted with parents, students, and colleagues (including teachers, principals, administrators, and other school personnel) from January - April, and staff/parent/student feedback surveys consisting of multiple choice responses, scaled rating responses, and short answer responses in April. Below is a summary of the partner feedback that was received

School Site Council Discussion: Discussion during our School Site Council meetings elicited parent and staff feedback around school concerns and improvement suggestions. To better support the student in achieving high levels and fostering a passion for lifelong learning, suggestions include enhancing interactive classes, expanding clubs and student activities both virtually and in-person, implementing an internship program and fostering community partnerships, developing additional curriculum, incorporating more student-led instructional design, providing more synchronous ELA and science instruction, initiating a book club and student-led initiatives based on student interests, and ensuring safe online activities for students. These measures aim to engage students more actively in their learning process and provide diverse opportunities for exploration and growth.

To enhance the experience as a JCS student, staff member, or parent-teacher, suggestions include increasing parent engagement, creating a stronger virtual community akin to in-person connections, offering clearer information about the school's identity and direction along with transparent outlines and expectations, improving the onboarding process for new families through surveys and additional resources, and streamlining communication channels to avoid overwhelming amounts of emails and texts. These ideas aim to foster a more supportive and inclusive environment while promoting effective collaboration and understanding among all stakeholders within the JCS community.

Some respondents indicate awareness of opportunities other schools offer that JCS currently does not, such as in-person schooling options, personalized learning campuses, sports programs, and increased social engagement opportunities. These suggestions highlight areas where JCS could potentially expand its offerings to provide a more comprehensive educational experience, encompassing both academic and extracurricular activities, and fostering greater social interaction among students.

Respondents expressed concerns about the future of JCS, focusing on the need to ensure the sustainability of the program while maintaining a high standard of education with a growth mindset. Balancing personalization with sustainability is highlighted as a challenge, particularly in the context of budget constraints limiting resources for customization. Additionally, there are concerns about stagnant enrollment numbers over the past one to two years, prompting questions about strategies to attract and retain students interested in virtual learning. Effectively marketing JCS and reaching its niche market of students are identified as key areas of focus for the future.

Two-Minute Conversation Campaign: Between January 2024 and April 2024, XX responses from parents, students, and staff at JCS-LIVE asked questions to elicit values, opinions, and information related to school improvement. According to the campaign responses, students and parents express varying degrees of satisfaction with the school, with some enjoying the program and finding it beneficial, while others have concerns or suggestions for improvement. Some common themes include the desire for more parental involvement and support, streamlined communication and expectations, increased social opportunities for students, personalized learning experiences, and adjustments to workload and curriculum to better meet individual needs. There are also suggestions for enhancing technological training, providing incentives for student engagement, and improving accessibility to counseling services. Overall, there is recognition of the efforts made by the school staff and a desire for continued improvement to better serve students and families.

When asked about how the school should focus its LCFF dollars on school improvement, the feedback revolves around several key areas for improvement, including technology upgrades (better computers, laptops, and internet connectivity), more diverse and engaging elective options, enhanced extracurricular activities, increased opportunities for in-person interaction and community building, and better access to resources like mental health services and academic support. Additionally, suggestions include investing in infrastructure improvements such as sports facilities, science labs, and school libraries. There is a common theme of addressing the needs of both students and staff to create a more conducive learning environment and foster a stronger sense of school pride and community.

Feedback focused on improving post-secondary outcomes for students highlighted a strong desire for practical life skills education, including financial literacy, career readiness, communication skills, and hands-on experiences in various trades and professions. Suggestions include incorporating courses on personal finance, job readiness, and practical skills like cooking, home repairs, and automotive maintenance. Many students and parents express a need for real-world experiences, such as job shadowing, apprenticeships, and career fairs, to better prepare for life after high school. Additionally, there's a call for improved technology and less stressful educational experiences, along with opportunities for practice interviews and aptitude tests to explore career options. Overall, there's a consensus that JCS could enhance its curriculum by offering more comprehensive life skills education and career preparation programs.

Overall, campaign respondents shared various reasons why families chose JCS-LIVE for their educational needs, including flexibility in scheduling, support for specific medical or learning needs, recommendations from friends or education specialists, dissatisfaction with traditional public school settings, and the desire for online learning options. While some families have considered leaving due to concerns about workload, organization, or socialization, many expressed satisfaction with the school's support, curriculum, and flexibility. Overall, families appreciate the personalized approach to learning and the ability to tailor education to their unique circumstances.

Parent Feedback Survey: In April 2024, 43 parents (including parents/guardians, grandparents, parents of students with a disability, parents of English Learners, and volunteers) participated in a spring survey asking them to share their concerns and provide feedback for school improvement. The concerns expressed by parents regarding their children's development and achievement vary widely. Some parents emphasize the importance of exploring career paths in technology rather than focusing solely on college. Others worry about their child's reading progress or the effectiveness of speech therapy. Some parents feel their children excel in life skills but suggest integrating real-life scenarios into academic assignments. Handwriting skills and spelling are also areas of focus for improvement. Social interaction, language development, and stress from academic pressure are common concerns. Parents of introverted children note the lack of social skill-building opportunities in online learning environments. Despite concerns, many parents express satisfaction with their child's school experience and support. They seek resources to aid in social interaction outside of school and advocate for more flexible grading options to reduce stress. Overall, parental input highlights the importance of a holistic approach to education that addresses academic, social, and emotional needs.

The feedback provided by parents regarding how JCS could better support their children in ELA, math, science, social studies, and P.E. includes suggestions for implementing peer tutoring, continuing homework clubs with more math tutors, and ensuring that Personalized Learning Plans (PLP) align with grade-level learning. Some parents emphasize the need for engaging yet easy-to-navigate curriculum materials, consistent offline and online resources, and additional activities like gym memberships for P.E. Some express satisfaction with teacher support while others inquire about funding for outside sports lessons. Overall, there's a desire for more in-depth tutoring in math, recognition of efforts by staff, and a call for improvement in areas such as curriculum customization and teacher guidance in subjects like science.

Parents also offer suggestions for enhancing the school's support for their child's social-emotional wellness, including organizing more social events that students are interested in, facilitating counselor meetings, and introducing classes covering common teenage problems and mental health issues. Some parents emphasize the importance of parental support in nurturing their children's social and emotional well-being. Others suggest utilizing check-in texts instead of emails and creating more group activities. While some parents feel satisfied with the school's efforts, others advocate for increased counseling services, on-site therapists, and more availability for counseling. One parent voices concern about early college pressure and proposes group discussions to address students' concerns. Overall, there's a recognition of the role of both the school and parents in supporting students' social and emotional development.

Staff Feedback Survey: In April 2024, 6 staff members (including administrators, Academy teachers, Home Study Educational Facilitators, Special education teachers, and classified staff) participated in a spring survey. Staff express concerns about their student's development and achievement, particularly regarding the perception of the school as “an easy way to earn credits” and students' lack of effort on assignments. They worry that this attitude towards learning will negatively impact their success, especially in college, where academic rigor is higher and extensions are not readily granted. Additionally, there are concerns about students' motivation and understanding of the value of learning, with some families tolerating cheating and students relying on AI for answers. Staff suggests that JCS could better support them by

providing a curriculum with more opportunities for customization, enforcing expectations for academic rigor and daily work completion, and addressing learning gaps with proper support.

To enhance student achievement in ELA, math, science, social studies, and P.E., staff suggests that JCS-LIVE could implement more live writing support in ELA and incorporate additional open-ended assignments for Edgenuity across subjects. They are exploring resources like the Exceptional Students Courses catalog for students with IEPs, which could provide valuable support. Furthermore, JCS-LIVE offers various support systems such as office hours, homework hubs, and tutoring hubs, which could be utilized more effectively. It's suggested to integrate short writing assignments into Edgenuity to reinforce vocabulary and to encourage students on IEPs to participate in live classes for more direct instruction and support, despite potential pushback from other teachers. Overall, the staff views the school positively in terms of supporting students across subject areas.

To enhance the school's support for students' social-emotional wellness, suggestions include regular check-ins with families and providing access to therapy for students, recognizing that mental health issues can hinder learning. The implementation of life skills classes and in-person events for students and teachers is emphasized to foster a sense of community. Additionally, integrating the Leader In Me curriculum, organizing a book study on "The 7 Habits of Highly Effective Teens," and sharing resources available in the local community are proposed strategies. Moreover, there are calls for more clubs and opportunities for students to build community, as well as the establishment of a school-wide social-emotional learning (SEL) curriculum with dedicated staff members to oversee its implementation at JCS-LIVE.

Student Feedback Survey: In April 2024, 92 students were surveyed about the school. The best thing about the school, as noted by various students, is the supportive and caring nature of the teachers, as well as the flexibility offered in terms of scheduling and learning environment. Many appreciate the individualized attention and support they receive, including mentorship programs and small class sizes. Students value the accessibility of teachers for help and guidance, as well as the accommodating approach to students' needs and learning styles. The ability to learn from home, the diverse range of extracurricular activities, and the welcoming atmosphere within the school community are also highlighted as positive aspects. Overall, students feel supported, encouraged, and valued in their academic journey at the school.

When asked what the school doesn't have they would like, students expressed various desires for additional offerings, including more sports interactions with other schools, amusement park field trips, increased social co-ops and events, and expanded trade opportunities alongside the current college prep focus. Some students suggest more field trips, enhanced support for struggling students, better math instruction, and additional elective choices. There are requests for unique classes such as ASL, drawing, or modeling, while others seek improved computer courses and financial education. Some students desire more extracurricular activities, athletic programs, or social interactions outside of school hours. Overall, there's a diverse array of requests, from academic enhancements to extracurricular expansions.

The LEA has internalized this feedback and embraced it within the development of the 2024/2025 Local Control Accountability Plan. The goals included in this LCAP are aligned to the state priorities and a majority of the metrics are required but the actions and services are inspired by our educational partners.

Feedback from partners suggests that students, parents, and staff generally express positive sentiments about JCS-LIVE citing small class sizes, supportive teachers, and the opportunity to improve academically with access to educational materials and curriculum choices. To ensure staff are trained and well supported, the LEA will take action to provide a funded induction program for new teachers and administrators who need to clear their credentials. The instructional materials provided by the school are paramount to student success; therefore, we will ensure they are accessible to all students, rigorous, and aligned to standards through actions related to curriculum analysis, adoption, and implementation, technology provisions and support, and programs and services for unrepresented students. While JCS-LIVE is an online school, it maintains offices for record keeping and resources; therefore, we will ensure that the facilities are safe for individuals who access our physical offices. Within the metrics, actions, and services below, we aim to maintain many basic services through tracking systems while attending to improvements in curriculum, resources, and facilities for all students and support services for students with special needs.

Based on the school's Academic Performance and College and Career Readiness Indicators on the 2023 CA Dashboard, as well as stakeholder input, we've determined the school needs to dedicate resources, time, and attention to providing high-quality, equitable, and responsive instruction so all students can succeed at high levels. While impressive growth in ELA academic achievement has been demonstrated over the course of the last LCAP cycle (2020-2023), as evidenced through CAASPP/CAST data, math performance has declined and all students must continue increasing communication and critical thinking skills. This is especially important for Students with Disabilities and unduplicated students who have lower performance levels on the CA School Dashboard. Additionally, secondary students need increased opportunities to be prepared for life after graduation and considered College and Career Ready including a-g course access, dual enrollment, and career-technical education (CTE) opportunities. Through a lens of equity, the school will focus on the needs of ALL students ensuring significant subgroups and unduplicated groups have comparable student outcomes. This includes the school's ability to support English Learners on their path to becoming fluent English proficient. We will monitor growth and make instructional decisions to impact achievement in differentiated areas of need throughout the school year using the NWEA MAP assessment. The identified metrics below will help us measure growth and tell us if the actions/services identified are making an impact and enabling us to address areas of student need authentically.

An explanation of why the LEA has developed this goal.

Feedback from stakeholders shows that overall our students and parents feel connected to and supported by their teachers and that the school provides a safe and nurturing environment. An analysis of data from the state and some local tools (such as our school information system) affirms this, demonstrating low and equitable suspension, expulsion, and drop-out rates for all students. Over 2021, the Chronic Absenteeism rate has been on the rise and JCS-LIVE has worked hard to increase student engagement and decrease chronic absenteeism. Unfortunately, a significant equity gap still exists for our socioeconomically disadvantaged students and they were placed in the “red” performance level for status and change on the 2023 CA Schools Dashboard, requiring a specific action/service for improvement. According to the 2023 CA Schools Dashboard, 22.2% of SED students are chronically absent which is a 5.6% increase from 2022. Additionally, an analysis of the 23/24 Holistic Student Assessment (HSA) results shows that the % of students placed in Tier 3 (most significant SEL needs) has decreased from 22% in 2022 to 18% in 2023. Further analysis of HSA revealed that Socioeconomically disadvantaged students (SED) need the most significant SEL support. SED students have the lowest percentage of Tier 1 students (29.4%) with the lowest number of average strengths and the highest number of average challenges, which we hope to address with a Student Engagement Paraprofessional. We also hope to address the SEL needs of all our students with the Leader in Me leadership program. To increase engagement, staff, students, and parents shared the following suggestions via survey: explicit tiered SEL support such as counseling services, music/art instruction, leadership opportunities, and interest-based electives. Research shows that many of these factors contribute to students feeling happy, secure, and engaged in a learning environment and behaving in ways that promote confidence, community, and integrity. Through the actions/services below, we will continue to monitor, maintain, and improve student engagement outcomes. These efforts serve to benefit our current students and grow/solidify our school by attracting increased enrollment. We will also address parent engagement since only 77% of parents responded that they believe the school includes them in decision-making. 2% did not think the school included them in decision-making and 21% were unsure.

Introduction and Instructions
