Our proposed ESSER III plan was developed based on previously identified school needs through the Expanded Learning Opportunities Plan (ELO Plan) and LCAP process. The administrative team identified priorities that were not able to be funded from other funding sources and ranked those priorities based on needs identified in the current school year. On 10/13/21 an email was sent via website to our SELPA (El Dorado) and on 10/22/21 an email was sent to the Campo tribal nation to review highlights of our proposed plan and gather feedback and suggestions on areas of concern they see with the student and family populations they serve. A link to our survey was sent to all three parties and they were encouraged to contact us directly to provide feedback.

On 10/18/21 and 10/20/21 we held virtual feedback sessions for parents, students, and staff (both general and special education, including administration) and sent a survey on 10/18/21. We reviewed our proposed plan and gave access to attendees to provide comments and suggestions on our proposed plan. The meeting was recorded and sent via email to our entire school community to watch the recording at a

time and location that was accessible for them. Those watching the recording were able to provide feedback on the plan through email or survey. The plan was submitted to our governing board on October 29th for review, discussion, and approval.

A description of how the development of the plan was influenced by community input.

16 people responded to the survey. 59% were parents, 26% were students 15% were staff. One JCS-Pine Valley parent and one JCS-Pine Valley student attended the Zoom meetings live. On the survey parent and staff respondents indicated the their greatest areas of concern are math (34%), the social/emotional impact of COVID (28%), and Language Arts (24%). Student respondents overwhelmingly indicated that College/Career Readiness was their greatest area of need. Respondents indicated that they felt the greatest impact for lost instructional time would come from additional tutoring sessions (52%), additional staff (42%), and smaller class sizes/EF rosters (27%), with the majority of students indicating additional staff or smaller class sizes. On the open-ended question respondents indicated that they would like more opportunities for students to connect with peers and have more experiential learning (i.e. field trips) and electives to help students re-engage. Parents of students with disabilities also see the need for additional support at school as well as peer interaction opportunities.

JCS-Pine Valley's ESSER III plan will include continuing the home study hub for another year, which allows students greater access to peer interaction. Continuing to pay for our instructional aide for another two years will allow students continued academic and SEL support, which parents, students and staff feel is important. Using ESSER III funds for these services will also allows us to allocate other funds to increase field trips and other experiential activities parents and students are looking for.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
