2017-20 Plan Summary The Story

Describe the students and community and how the LEA serves them.

Julian Charter School (JCS) is an independent study K-12 charter school sponsored by the Julian Union Elementary School District. JCS currently serves approximately 245 students from San Diego, Orange, and Riverside counties. Julian Union, a small district in San Diego County, founded JCS in November 1999 to meet the needs of students underserved by traditional systems and for families with a strong desire to home school. JCS grew to serve over 2500 students over the years with homestudy and hybrid independent study options. Due to a change in independent study law in 2018 JCS had to re-group and split into six different charter schools. Today Julian Charter serves home study students only, and many of its former students have become part of the JCS-Inc family, which includes five other schools in San Diego and Riverside counties under various authorizers. Julian Charter School now offers homestudy only. For the upcoming 2019-2020 school year we plan to make JCS a synchronous online school serving grades 6-12 only and will be calling the school JCS LIVE. The target enrollment will be 90 students for the first year.

The mission of JCS LIVE is to provide an alternative classroom setting tailored for students who desire a synchronous, online, personalized environment focused on Career and Technical

Education. We are dedicated to excellence and committed to nurturing passionate lifelong learners. Core values include:

- Creativity and Innovation: Envision and explore rich teaching and learning opportunities.
- Commitment: Educate students to their full potential and uphold the greater good of the school.
- Choice: Empower individual paths and goals through personalized learning.
- Excellence: Foster a climate of high expectations, quality, and accountability.
- Integrity and Compassion: Model honesty, dignity, fairness, and responsibility while demonstrating respect and understanding.

JCS LIVE teachers and staff are committed to helping every student achieve and succeed. Educators inspire and empower students to reach their goals. Students feel a sense of community and support even though they are working from home. Students interact with teachers and have opportunities to interact with peers as well. Our goal at JCS LIVE is to build skills and develop a love for learning and develop the foundation for life success. We utilize vetted and personalized curriculum designed to build skills and interest in all of our students. Students will receive kits each month filled with activities and individualized items to make learning fun.


The main JCS office is located at the Julian Union district's middle school campus. In addition to housing the main office staff, the building is a meeting location for special education services for students in Julian and the surrounding communities.

Our student population consists primarily of white students (69.4%) and hispanic students (20.8%). Our special education population is large in comparison to most districts (17.6%). This is a huge increase over previous years, which were more in line with traditional districts. The significant increase is due to the split into six schools, at which point Julian Charter School needed to support all of the 12th grade students until our other JCS families could receive WASC accreditation.

Due to the nature of independent study, our English language learner population is extremely small (only 1.6%), since for at least a portion of the week the parent is the teacher for the student. Our socioeconomically disadvantaged population is 28.6%, and our homeless and foster youth make up 1.2% of the population. While we don't have a migrant population in the traditional sense, we do have a somewhat transient population: Some families decide that home study is not the right "fit" for them, while others move back and forth between different charter schools looking for different resources and schedules.

Of the current state indicators on California's LCFF Dashboard, JCS is in good standing overall for student performance in ELA and Math. Our math performance indicator increased due to an 8.5 point growth over the past year. Our students with disabilities and Hispanic students performed low in Math in 2017-2018. Our students with disabilities and English Learners performed low in ELA in 2017-2018. Our graduation rate is considered low at about 84%, although we increased that rate by 2.2% in 2017-2018. This low rate is in part due to the number of students who come to us that have not been successful in other, more traditional settings and are graduating in more than 4 years. Although our number of English Learners has historically been small, over 38% of our English Learners from 2017-2018 achieved "Well Developed" on the new ELPAC assessment and 31% achieved "Moderately Developed."

Students come to JCS for various reasons: some are looking for an option other than their local school because they aren't happy with what their local school has to offer while others prefer the traditional home study model with the flexibility and choice in curriculum and daily schedule. Because JCS covers such a large geographical area, our student demographics and needs vary somewhat depending on the region. As a school we look at data by county and grade level (K-8 and 9-12) and as a whole to identify our students' needs. While JCS strives to support all learners in meeting their potential, we are very aware of our struggling and at-risk learners and their diverse needs and are constantly striving to provide additional supports.

1) academic achievement for all students, with particular emphasis on low performing students 2) preparing lifelong learners who are ready to enter the world of work or college through internships and concentrated career and technical education paths in their field of interest Goal 3: Pupil engagement: empowering students to be active participants in their education by building a supportive learning culture that is safe, nurturing, and curriculum-rich.

Greatest Progress

Math and college/career readiness are the two areas we've identified as being of greatest need. Our math coach has been with us for three years and has continued to be a great resource for both teachers and parents. In addition to the standards-based common assessments which have been

created an implemented, our math coach has created a website with a wealth of resources for homestudy parents. We've continued to use ST Math, and our math coach is tracking their growth in math achievement to see if this is a resource we'll expand. During the 2018-19 school year 9th graders were asked to participate in CTE courses through Odysseyware, an online curriculum provider. Students began their studies with introductory courses in their chosen pathway. We've increased the number of 8th grade students taking PSAT and, using those scores, have begun to help them create a College Board account which links to a personalized learning path for math on Khan Academy.

Our high school counselor organized two college tours for high school students and two college tours for our middle schools students in 18-19. We continue to explore a Dual Enrollment community college program with. We've also begun to put together a career technical education (CTE) program using an online program. Students participated this past year in the beginning courses and we plan to expand upon that in 2019-20.

Although our English learner population is low we invested in purchasing an ELD curriculum aligned with the new ELD standards for Designated ELD. The curriculum combines online work with supplemental book materials to allow students to work at home while being monitored by staff. We hope that this additional support will encourage students to remain with us longer and improve their English language proficiency.

During the 2018-19 school year 9th graders were asked to participate in CTE courses through Odysseyware, an online curriculum provider. Students began their studies with introductory courses in their chosen pathway.

Greatest Needs

Our graduation rate is considered low, with our overall graduation rate at 83.6%. However, our adjusted 9-12 dropout rate on DataQuest is 1.4%. For 2019-20 we'll be looking at our cohort data, as the new calculations have been established, to better understand our cohort population. Career and College Readiness will be the main focus of JCS LIVE, with an emphasis on Career and Technical Education.

Performance Gaps

Our English Learners and our Students with Disabilities performed two performance levels lower than our "all student" group in ELA for 2017-18. We will be implementing our new curriculum for Designated ELD to support our English learners including weekly groups for practicing the speaking standards. EL students who aren't making progress will be pulled in to our MTSS model for Tier 1 or Tier 2 intervention. We'll continue to look at the supports in place for our Students with Disabilities along with the benchmark assessments and curriculum in place.

With the split of JCS into six small schools Julian Charter has undergone an enormous change, but we believe we've done a good job of implementing the actions/services overall. While we didn't implement the ELD curriculum we purchased, it's given us time to determine how best to use it to serve students at home and how to promote parent implementation.

Our indicators on the LCFF Dashboard show that we're making steady progress overall. We need to continue to find ways to help our students with disabilities make progress, and we need to look more closely at our low income student data to see where they may need additional support. College and career readiness is still our biggest area of need.

Due to a significantly smaller budget as a small school we were not able to hire or retain all the personnel we had planned for. We did have more students use EUs for tutoring than anticipated.

Our low income and English learner populations have increased over time. Low income makes up 30% of our population. While English learners are only at 1%, this is a significant increase in the past few years. In 2018-19 we're continuing to improve our process of early intervention with an emphasis on unduplicated students. We're also improving our EL services by purchasing new EL curriculum and providing a structured designated ELD program. In 2018-19 we'll be looking more closely at the data for our low income students to see where there is overlap with other at risk groups and identify their needs.

Julian Charter School serves a very small number of students identified as low-income pupils, foster youth and English learners. These students are spread proportionally throughout all grades, K-12. The goals articulated and documented above will be carried out throughout our charter school programs; however targeted students will receive priority access to programs cited in the goals and action steps. While all programs are available to all students in our charter school data will be collected and analyzed to ensure targeted students are making progress as a result of the LCAP programs. The Charter is spending the LCAP allotment specifically on student improvement and well being with a focus on EL Students, foster/homeless youth, and low income students.

Addendum

Priority 3: Parental Involvement addresses:

- A. The efforts the school district makes to seek parent input in making decisions for the school district and each individual school site;
- B. How the school district will promote parental participation in programs for unduplicated pupils; and
- C. How the school district will promote parental participation in programs for individuals with exceptional needs.

Priority 4: Pupil Achievement as measured by all of the following, as applicable:

- A. Statewide assessments;
- B. The Academic Performance Index;
- C. The percentage of pupils who have successfully completed courses that satisfy University of California (UC) or California State University (CSU) entrance requirements, or programs of study that align with state board approved career technical educational standards and framework;
- D. The percentage of English learner pupils who make progress toward English proficiency as measured by the California English Language Development Test (CELDT);
- E. The English learner reclassification rate;
- F. The percentage of pupils who have passed an advanced placement examination with a score of 3 or higher; and

 - (1) The number of K-8 students who were absent 10 percent or more of the school days excluding students who were:
 - (A) enrolled less than 31 days
 - (B) enrolled at least 31 days but did not attend at least one day
 - (C) flagged as exempt in the district attendance submission. K-8 students are considered to be exempt if they:
 - (i) are enrolled in a Non-Public School
 - (ii) receive instruction through a home or hospital instructional setting
 - (iii) are attending a community college full-time.
 - (2) The number of students who meet the enrollment requirements.
 - (3) Divide (1) by (2).
- (b) "High school dropout rate" shall be calculated as follows:
 - (1) The number of cohort members who dropout by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.
 - (2) The total number of cohort members.
 - (3) Divide (1) by (2).
- (c) "High school graduation rate" shall be calculated as follows:
 - (1) For a 4-Year Cohort Graduation Rate:
 - (A) The number of students in the cohort who earned a regular high school diploma by the end of year 4 in the cohort.
 - (B) The total number of students in the cohort.
 - (C) Divide (1) by (2).
 - (2) For a Dashboard Alternative Schools Status (DASS) Graduation Rate:
 - (A) The number of students who either graduated as grade 11 students or who earned any of the following:
 - (i) a regular high school diploma
 - (ii) a High School Equivalency Certificate
 - (iii) an adult education diploma
 - (iv) a Certificate of Completion and was eligible for the California Alternative Assessment if under the age of 20.
 - (B) The number of students in the DASS graduation cohort.
 - (C) Divide (1) by (2).
- (d) "Suspension rate" shall be calculated as follows:
 - (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was suspended during the academic year (July 1 June 30).
 - (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).
 - (3) Divide (1) by (2).
- (e) "Expulsion rate" shall be calculated as follows:
 - (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was expelled during the academic year (July 1 June 30).
 - (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).

(3) Divide (1) by (2).
